

THATTUTORGUY.COM RELEASE AGREEMENT

ThatTutorGuy.com LLC (with its successors in interest, licensees, agents, and representatives, collectively, "TTG") is engaged in a project tentatively entitled "Commercial No. 1 for Youtube (the "Video"), and I, the undersigned, in return for a transferable free three-month subscription to the TTG website, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, agree to appear in the Video, and further agree and acknowledge that my name, voice, and image that I recorded by various mechanical and electrical means of all descriptions (such recordings, any piece thereof, the contents therein and all reproductions thereof, along with the utilization of my name, voice, and image shall be collectively referred to herein as the "Released Content").

Understanding that TTG may invest considerable sums relying on my promises, I hereby freely and without restraint irrevocably consent to and give to TTG and anyone authorized by the TTG, the unrestrained right in perpetuity to own, utilize, or alter the Released Content, in any manner TTG may see fit and for any purpose whatsoever, without credit or compensation to me, all of the foregoing to be without limitation of any kind, throughout the universe, in any media now known or hereafter devised, and in perpetuity. Without limiting the generality of the foregoing, I hereby authorize and grant unto TTG the unrestrained rights to utilize the Released Content in connection with the Video and the advertising, publicity, public displays, and exhibitions of TTG's commercial website(s), service(s), and business(es). I hereby stipulate that the Released Content is the property of TTG to do with as it will, and that TTG may alter, use, decline to use the Released Content, in its sole discretion.

I hereby irrevocably waive to the fullest extent that I may lawfully do so, any so-called artist's or moral rights, as well as any causes of action in law or equity I may have or may hereafter acquire against TTG for libel, slander, invasion of privacy, copyright or trademark violation, right of publicity, or false light arising out of or in connection with the utilization by TTG or anyone authorized by TTG of the Released Content. This is intended to be a general release, and I hereby waive the provisions of California Civil Code Section 1542 (and any similar law in any other jurisdiction), which states:

A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor.

I hereby represent and warrant to TTG that I have received no other inducement or promises to enter into this Release other than those stated herein, that I am over the age of eighteen and of the age of majority in my jurisdiction, and that I have read, understood, and agreed to each and every provision of this Release. This Release shall be governed by the laws of the State of California and of the United States of America and any claims or controversies regarding it shall be resolved solely in the state and federal courts geographically located in Los Angeles County, California, and I hereby irrevocably waive any argument that such is an inconvenient forum. This Release may be executed in counterparts and/or electronically.
